- **Mass Youth & Leagues Committee**
 - Mass Youth Soccer website is up to date for the spring season.
 - MTOC is being held during the final weekend in June.
 - MTOC Roster Freeze deadline was extended to May 24th.
 - MTOC will be round robin style
 - SSSL has 3 wild card(wild cards are randomly drawn)
 - G6.2 G8.1 B8.2
- **Spring Season**

- Rules
 - Bylaw 10.3. - Reason: to allow for both seasons, not just spring.
 - Rule 4.4. - Reason: To allow towns to for better notification of closed facilities; also to move Div 3 games to be played on Saturday along with 5 divisions of Gr 4 teams.
 - Rule 5.2 - Reason: “see rule 5.3” – clarify procedure. Yellow portions – request rejected is in rule 5.3; repeated Saturday & Sunday. Add Friday advance notice of 7 days – it is harder to get a three-person set of Referees on short notice to cover on a Friday night.
 - Rule 7.6 - If a S.S.S.L. Play-Off Game is still tied after regulation play two full extra time periods will be played of the following length
 - (1) Gr9/10/11 and younger shall be 10 minutes
 - (2) Gr11/12 and older shall be 15 minutes
 - (3) And if still tied then F.I.F.A. penalty kick rules shall apply
 - Rule 9.4 - Reason: To remove co-ed restrictions
